Genomic DNA was extracted from Aspergillus fumigatus, strain B6081.

Aspergillus fumigatus (A. fumigatus), strain B6081 is an environmental isolate obtained in 2002 in Montréal, Québec, Canada.¹

NR-50386 has been qualified for PCR applications by amplification of approximately 1200 base pairs of ribosomal RNA and internal transcribed spacer (ITS) region.

Material Provided:

Each vial of NR-50386 contains 0.2 μg to 3.5 μg of DNA in TE buffer (1 mM Tris-HCl, 0.1 mM EDTA, pH \sim 8). The concentration is shown on the Certificate of Analysis. The vial should be centrifuged prior to opening.

Packaging/Storage:

NR-50386 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -20°C or colder immediately upon arrival. Freeze-thaw cycles should be minimized.
