Virus Classification: *Paramyxoviridae, Morbillivirus*

Species: Measles virus

Strain/Isolate: MVs/Missouri.USA/15.18 [D8]

Genotype: D8

Original Source: Measles virus (MeV), MVs/Missouri.USA/15.18 [D8] was collected from a nasopharyngeal swab in April 2018 in Missouri, USA, and isolated on October 8, 2019.<sup>1</sup>

Comments: MeV, MVs/Missouri.USA/15.18 [D8] belongs to genotype D8 and the sequence of the nucleoprotein gene is available (GenBank: [MH281735](https://www.ncbi.nlm.nih.gov/nuclseq/MH281735)).

MeV is a single-strand negative sense non-segmented RNA virus.<sup>2</sup> MeVs are divided into 8 clades, designated A through H, with 24 genotypes based on the sequences of the hemagglutinin (HA) and nucleoprotein (N) genes. The sequence of the 450 nucleotides that encode the carboxyl-terminal 150 amino acids of the nucleoprotein (N-450) is needed to determine the genotype.<sup>2,3</sup> In 2018, four new genotypes were identified: B3, D4, D8 and H1. In 2000, measles was declared eliminated in the US by the WHO, but in 2019 the highest numbers of cases and outbreaks were reported.<sup>4</sup>

**Material Provided:**

Each vial contains approximately 1.0 mL of cell lysate and supernatant from *Cercopithecus aethiops* kidney epithelial cells with human signaling lymphocytic activation molecule (Vero E6-hSLAM) infected with MeV, MVs/Missouri.USA/15.18 [D8].

Note: If homogeneity is required for your intended use, please purify prior to initiating work.

**Packaging/Storage:**

NR-52250 was packaged aseptically in screw-capped plastic cryovials. The product is provided frozen and should be stored at -60°C or colder immediately upon arrival. For long-term storage, the vapor phase of a liquid nitrogen freezer is recommended. Freeze-thaw cycles should be avoided.

**Growth Conditions:**

Host: *Cercopithecus aethiops* kidney epithelial cells with human signaling lymphocytic activation molecule (Vero E6-hSLAM)

Growth Medium: Dulbecco's Modified Eagle's Medium containing Earle's Balanced Salt Solution, non-essential amino acids, 2 mM L-glutamine, 1 mM sodium pyruvate and 1500 mg per L of sodium bicarbonate supplemented with 2% fetal bovine serum, or equivalent

Infection: Cells should be approximately 90% confluent

Incubation: 2 to 4 days at 37°C and 5% CO<sub>2</sub>

Cytopathic Effect: Syncytia formation
